





Some of our goals include reducing the time from initial screening to diagnosis and reducing the time from definitive diagnosis to treatment in a more aesthetically pleasing facility. Our new breast center will help us bring the latest technology and breast care specialists together to enhance the patient care and experience for women in our community and the Lakelands region.

Funding for these two projects will come from two sources: philanthropy and cash reserves budgeted by the hospital knowing that these service enhancements are in the works. The investment for these two programs is estimated to total \$8 million. These two projects have the potential for touching countless lives in our community as all of us know of a family member, co-worker, friend, or neighbor that has been touched by one of these cancers.

## **Estate Planning**

#### It's time to create, or update, estate plans

If you haven't created an estate plan, or have one but the documents may be outdated, you might be putting yourself and your family at risk if the unthinkable, such as becoming incapacitated or passing away, should happen to you. To assist you with getting started on creating or updating your plan, it helps to understand these five important documents that are part of many estate plans:

#### 1. Will

A will provides instructions for when you die. You appoint a personal representative (or "executor") to pay final expenses and taxes and distribute your assets. Remember that beneficiary designations on 401(k) plans, IRAs, insurance policies, etc., supersede what you have in your will. If you have minor children, a will is the only way to designate a guardian for them.

#### 2. Durable power of attorney

A power of attorney lets you name an agent, or attorney-in-fact, to act on your behalf. You can give this individual broad or limited management powers. Choose them carefully because they will generally be able to sell, invest, and spend your assets. A traditional power of attorney terminates upon your disability or death. However, a durable power of attorney will continue during incapacity to provide a financial management safety net. A durable power of attorney terminates upon your death.

#### 3. Health care power of attorney

A durable power of attorney for health care, also called a health care proxy, authorizes someone to make medical decisions for you in the event you are unable to do so yourself. This document and a living will can be invaluable for avoiding family conflicts and possible court intervention if you're unable to make your own health care decisions. Remember to review this document regularly to ensure the right person is designated to make any necessary medical decisions.

If you are a parent, be aware that once a child turns 18, you need a health care power of attorney for them so you can engage with their medical professionals.

#### 4. Living will

A living will expresses your intentions regarding the use of life-sustaining measures in the event of a terminal illness. It expresses what you want but does not give anyone the authority to speak for you.

#### 5. Revocable living trust

By transferring assets into a revocable trust, you can provide for their continued management during your lifetime (when you're incapacitated, for example), at your death, and even for generations to come. Your revocable living trust lets trust assets avoid probate and reduces the chance that personal information will become part of public records.

Along with working with an attorney to create or update these, and possibly other estate planning documents, remember to:

- Make sure your loved ones are able to access your documents or know whom to contact (such as your attorney) when they need them.
- Go over account titling, powers of attorney, and successor trustee provisions to be certain the right individuals have access to funds.
- Determine who should have information on electronic passwords and online banking access so they can access information, update automatic payments, etc.

## A Message from our President and CEO

Dear Friends:

It is hard to believe that more than a year has passed since I stepped into the role of President and CEO of Self Regional Healthcare. What a year it has been.

In my 2021 Donor Report message to you, I mentioned my vision for Self Regional and our goals to be the best place to get care, the best place to give care, and for Self Regional Healthcare to continue to be financially sound. These goals can be moving targets, but I am pleased to report that we have made great progress toward reaching these lofty goals.

Recently, Self Regional had its CMS accreditation survey from DNV, our accreditation agency. This rigorous, organization wide inspection occurs every three years. Surveyors were on site to evaluate clinical quality, patient and team member safety, policies, and procedures. This was our first inspection since the pandemic outbreak, and I am happy to report that Self Regional had a great inspection. The surveyors shared with us that our hospital had one of the most positive cultures of the hospitals they have visited in the last year.




No doubt you have seen or heard some of the news about a possible affiliation with the Abbeville Area Medical Center. Self Regional and AAMC have signed a letter of intent to formally pursue the affiliation. Many details are still being worked out, but we anticipate the affiliation to be complete later this year. We are excited to be partnering with our neighbor to enhance the services to the Abbeville community.

One of our top concerns is the need to recruit new physicians and other clinical staff. We have added a number of new services over the last year including advanced robotic surgery in urology, general surgery, and gynecology, advanced cardiac imaging services, and podiatry, among others. We also recognize we have a growing number of physicians approaching retirement age. We are developing a medical staff recruitment plan to continue to meet the healthcare needs in both primary care and specialty care in our communities. This is a very high priority for Self Regional Healthcare because we want to provide a seamless continuum of care for the patients of our retiring physicians. Additionally, the nursing shortage continues to challenge us, but we are working very closely with our friends at Lander University, Piedmont Technical College, and even area high schools, to encourage young people to consider entering nursing and other healthcare careers.

The ER renovation project that was delayed during the Covid pandemic is now underway. The initial phases – moving part of the radiology suite and pain management suites, are already underway. There will be much more activity in the main part of the ER in the coming months. We anticipate the project will be completed in the fall of 2024. The new ER will have more rooms, an observation unit, enhanced fast track area for lower acute conditions, and is designed to improve the experience of our patients and team members. I am very excited about the enhancements allowing us to better serve the community!

As we are coming out of the pandemic, many challenges lie ahead, but we are positioned for success. We are committed to continue to improve our services to the community. Our goals remain the same. We will continue to strive to be the best place to get care – to me this means provide high quality care in a loving environment that we can all be proud of. We will continue work to become the best place to give care – we will take care of our team members and provide a good working environment that fosters team work and caring. We will remain financially sound. Thank you to the people and businesses recognized in this Donor Report. With a MyChart account, you can access your records at most Self Regional hospital visits and most Self Regional practices, both primary care (such as family medicine, internal medicine or pediatrics) and specialty care (such as cardiology, orthopedics or surgery).

Healthcare is constantly changing, and Self Regional Healthcare continually adapts to meet the healthcare needs of our community. To remain on the leading edge of technology and constantly improve your experience, Self Regional uses one of the most well-known EHR systems in healthcare, Epic. MyChart is a free online tool provided by Epic that serves as a centralized location for your health information.

MyChart enables you to see key parts of your medical record, communicate with your care team and engage in your own care like never before. You can also use MyChart to manage the health information of other family members.
